1. Purpose / situation

2.1 Chair's Action

3.1 Chair's Action

There have been three occasions where Chair's Action has been taken on behalf of the Committee.

The Chair's Actions approved the:

- All Wales Information Governance Policy;

- All Wales Internet Use Policy

The Policies have been developed on an All Wales Basis and all NHS Wales bodies were asked to adopt these policies. The Business Executive Team considered them on 6 July 2021 and approved their submission to Committee; the next available meeting of the Committee was not until 15 September 2021.
