1. Purpose / situation

The purpose of this report is to provide an update to the Audit and Corporate Governance Committee on the current compliance with Welsh Health Circulars issued by the Welsh Government.

2. Background

The Board Business Unit maintain a tracker for monitoring and recording the Welsh Health Circulars that are received by the Trust. The WHCs are sent to the relevant Eexecutive Lead for action, and the completion of actions are recorded within a central record log.

Internal Audit - Limited assurance Report

In May 2020, the Welsh Health Circular process was part of an Internal Audit Report on the management alerts, which received a limited assurance rating. Following the Audit, the process has been revised for recording and monitoring responses to Welsh Health Circulars, to ensure additional checks were put in place to proactively monitor the Welsh Government website to ensure all WHCs are logged, circulated and communicated around the Organisation in a timely manner.

Attached at appendix 1 is the latest update from the WHC log covering the period 1 January 2022 to 31 August 2022. 19 Welsh Health Circulars have been received in total during this period.

In line with the agreed process, the Welsh Government website has been checked regularly to ensure that there are not any WHCs issued that had not been received.

Of the 19 WHCs received:

- 2 were for compliance
- 17 were for action and/or information and/or compliance

Following the review of the WHCs, 7 of the 19 received were not applicable to Public Health Wales. These were:
