The HARP Programme also delivers education and best practice sharing opportunities through its programme of Antimicrobial Stewardship and Infection Prevention and Control Forums, which have been re-established post COVID with Summer forums held for both. We are also involved in Priority 1 – 'Helping patients get a final diagnosis faster.' For example, we have been part of the recently established Syndrome Without A Name (SWAN) clinic evaluation discussions and CARIS will receive data from that clinic.
