1. Purpose / situation

The purpose of this report is to present the revised Knowledge, REsearach and Information Committee Terms of Reference.

A review of the Knowledge, Research and Information Committee Terms of Reference took place and suggested amendments were approved by the Board on 25 November 2021.

2. The review followed a period where the Committee has not been operating as a result of the COVID-19 pandemic. Background

The Committees Terms of Reference of KRIC were last reviewed in November 2019. The Terms of Reference of Committees should be reviewed annually to ensure compliance with Standing Orders.

On 25 March 2020, in response to the Covid-19 Pandemic, the Board agreed to suspend KRIC during 2020/21.

On 29 July 2021, the Board agreed to resume KRIC in the 3rd quarter of 2021/22: the first meeting is scheduled for 8 December 2021.

Prior to the recommencement of the Committee, a review of the terms of reference took place, and the revised version of the Terms of reference were approved by the Board on 25 November 2021.

Attached at Appendix 1 are the revised terms of reference for the Knowledge, Research and Information Committee.

3. Summary of changes to Committee Terms of Reference

The changes are detailed in the table below, with the updated draft terms of reference included in full as appendix 1

One of the changes was that Cyber Security and Information Governance compliance were removed from the KRIC Terms of Reference. During 2020/21 when KRIC was suspended, these elements were temporarily remitted to the Audit and Corporate Governance Committee (ACGC). It was approved by the Board that this arrangement continued on a permeant basis.

It is noted that there will Information Governance considerations within the data remit of KRIC, but it was agreed that the compliance elements of this best align with the remit of ACGC.
