## 1. Purpose / situation

The purpose of this report is to provide the outcome of a review of the Terms of Reference of the Public Health Wales Health And Safety Group for approval.

## 2. Background

In line with part 3 of the Standing Orders and Scheme of Delegation - the Public Health Wales Board shall nominate annually a group to be known as the Trust Health and Safety Group. The Group is a formal Sub-Group of the Quality, Safety and Improvement Committee.

In order for the Board to discharge its responsibilities, it needs to receive assurance that the organisation is effectively managing health and safety, highlighting any concerns and areas of non-compliance and to monitor action plans developed to address actions identified.

The Health and Safety Group receives exception reports from the various directorates/divisions; these outline any concerns within their divisions and what actions or controls have been put in place to mitigate hazards and any risks identified. As part of the Group's governance arrangements a set of terms of reference has been developed and agreed.

### 3. Assessment

The terms of reference set out the purpose and operational arrangements of the Trust's Health and Safety Group and specifically in relation to;

- the provision of advice and assurance to the People and Organisational Development Committee, the Board and the Accountable Officer
- approval of procedural and written control documentation
- the group's delegated powers and authority
- Chairing and access arrangements to the group
- the establishment of sub groups to undertake appropriate related business
- membership and attendance arrangements
- secretariat arrangements
- quorate criteria
- requirements and responsibilities of the group in relation to the organisation's Standing Orders
- review arrangements for the terms of reference

As reported through the quarterly Health and Safety Report, as a result of Covid-19 response the original Health and Safety Group was stood down and a smaller group consisting of Health and Safety leads across the organisation established to manage the health and safety issues arising due to Covid-19 and to ensure we could consider issues in a timely manner.
