1. Purpose / situation

Public Health Wales is required to provide an Accountability Report as part of the Annual Report and Accounts for 2019/20. Guidance on how to complete and display these reports has been issued by Welsh Government Manual for Accounts, and by HM Treasury in the Financial Reporting Manual (FReM).

The Audit and Corporate Governance Committee considered an earlier draft of the Corporate Governance Report and Remuneration and Staff Report at its meeting on 18 May 2020. Following the meeting, changes were made to the document to reflect the feedback received at the meeting. A revised version of this document was submitted to the Welsh Government and the Wales Audit Office for review. Comments were received from Welsh Government and Wales Audit Office and have been incorporated into the final draft.

The final draft is to be considered by the Audit and Corporate Governance Committee at its meeting on 23 June 2020, for recommendation to the Board for approval at its meeting on 25 June 2020.

2. Background

- 1.1 NHS bodies are required to publish, as a single document, a three part Annual Report and Accounts which includes:
 - 1) The Performance Report, which must include:
 - An overview
 - A Performance analysis.
 - 2) The Accountability Report, which must include:
 - A Corporate Governance Report
 - A Remuneration and Staff Report
 - A National Assembly for Wales Accountability and Audit Report.
 - 3) The Financial Statements, including the Audited Annual Accounts 2019-2020.

In response to the COVID-19 pandemic, Audit Wales and Welsh Government confirmed a revised submission dates for annual report and accounts of the 30 June 2020.

The deadline date for the performance report is now the 30 September with the Annual General Meeting being held by the 30 November 2020.

The Accountability Report demonstrates how Public Health Wales meets key accountability requirements to the Welsh Government and is required to have three sections:

The Corporate Governance Report (Annexes 1-4)

This explains the composition and organisation of Public Health Wales' governance structures and how they support the achievement of the entity's objectives.

Remuneration and Staff Report (Annex 5)

This contains information about the remuneration of senior management, fair pay ratios, sickness absence rates.

National Assembly for Wales Accountability and Audit Report (Annex 6)

This contains a range of disclosures on the regularity of expenditure, fees and charges, compliance with the cost allocation and charging requirements set out in HM Treasury guidance, material remote contingent liabilities, long-term expenditure trends, and the audit certificate and report.

The Board Secretary and Head of Board Business Unit is responsible for the production of the Corporate Governance Report. This has been supported by consultation with Executive team members. The Remuneration and Staff Report has been produced by the People and Organisational Development Directorate and the Parliamentary Accountability and Audit Report has been produced by the Operations and Finance Directorate.

A revised draft of the Corporate Governance Report and the Remuneration and Staff Report were submitted to Welsh Government on 22 May 2020.

The Audit and Corporate Governance Committee will be reviewing the final draft of the Accountability Report at its meeting on 23 June 2020, a verbal update will be provided to the Board.

The Financial Accounts and the Audit Wales Annual Opinion (ISA 260) will be finalised and provided to the Board prior to the meeting.

3. Description/Assessment

The Accountability Report is **attached** for Board approval.

The Manual for Accounts states that the Corporate Governance Report must include the:

- Directors' Report (Annex 1)
- Statement of Accountable Officer's Responsibilities (Annex 2)
- The Annual Governance Statement (Annex 3)

It also states that where information required within the Directors' Report is disclosed elsewhere in the Annual Report and Accounts a cross-reference may be provided. As the majority of the information is contained elsewhere, the Directors' Report is presented in the form of a table.
