JW welcomed everyone to the meeting, being held as the covid-19 pandemic continued its global spread, with over three million people infected and over 200,000 deaths world-wide. Close to 900 people had lost their lives in Wales, a number from the health and care family. The Board observed a minute silence in their memory.

**PHW60/2020      Board Assurance Framework****Novel Coronavirus (COVID-19)**

The Board received an update report on COVID-19 (ref [4.1.1.300420](#)); this brought together those key areas also reviewed during the course of the weekly Board briefing sessions. Discussions centred on:

**Closed Settings**

JA summarised the work underway to support the care home sector, including the management of outbreaks, and consideration of widening the current testing regime, to possibly incorporate point of care testing.

SP noted the need for a sound epidemiological underpinning of the approach and the importance of public confidence; care home testing continued to attract wide public comment.

TC outlined the strategic approach under development; Andrew Jones was engaged in this work and she would ask him to provide a written briefing. TC would also forward a letter to the sector from Frank Atherton and Albert Heaney, setting out how the public health system would support care homes.

**Action AJ, TC**

JW thanked JA and TC for the update; given the significance of the care home sector, she requested specific reports on this sector for future meetings, together with reports on the prison sector, another significant closed setting. In the latter context, she referenced a recent report from Public Health England on the management of COVID-19 in prisons in England and Wales. QS commented on this report and the proposed communications with Public Health England.

**Action JA, QS****Public Health Protection Response Plan (the Plan)**

JW extended Non-Executives' warmest congratulations to Executive colleagues and the whole team involved in the production of the Plan; this had been a phenomenal undertaking, conducted at pace; it reflected fully the team's wealth of expertise, and set out clearly all the Public Health Wales advice on the actions needed for the next phase of COVID-19, together with the urgency of the situation.

TC reported that she had issued the Plan to trusted colleagues the previous evening, in line with the request from the CMO; recipients had until 5pm on May 1 to respond; the team would analyse the responses over the week-end and 'hand over' the final Plan to Welsh Government on May 4, for Welsh Government to consider.

TC then drew the Board's attention to Part 3 of the Plan; this set out the advice on the key critical policy decisions, enabling actions and key actions needed by the 7 May. QS outlined the benefit of forwarding the Plan to those attending the Public Health Wales Strategic Co-ordinating Group meeting on 1 May; membership included SCG chairs and LRF representatives and the meeting offered an opportunity to engage directly with key partners. He was waiting for confirmation of his request to this effect.

AW updated the Board on discussions with local government Chief Executives and representatives of environmental health officers.

TC noted the first meeting of a Welsh Government programme board that afternoon; which provided an opportunity for initial feedback. The Board would have a further update early in the coming week, following the analysis of the feedback.

### **Workforce Update (ref [4.1.2.300420](#))**

RB-W reflected on the major ask being made of all staff, a number of whom were working long hours and at significant pace. She took the Board through: the resources and support in place for staff; arrangements for effective redeployment and mutual aid; the practical advice and support offered; the temporary variations to the People policies, as set out in Appendix A. Looking ahead, RB-W outlined the issues and risks, together with the workforce challenges associated with the organisational recovery plan.

QS and MB reflected on the balance needed to ensure that the health protection function retained the workforce resources needed for the COVID-19 response, whilst still enabling vital work on the societal and population health implications of the pandemic to continue.

KE asked for clarification around the 500-550 staff identified as being on civic duties; RB-W explained that this data was not accurate and was in the process of being updated and cleansed. SB expanded into this point, confirming that managers were in regular contact with these staff and agreeing work packages; many staff were also volunteering. RB-W agreed to update the explanation given, to provide greater clarity

#### **Action RB-W, SB**

JW thanked RB-W for this update and expressed the Board's understanding of the unique working environment staff found themselves in, and appreciation for their willingness to adapt so readily. The Board would convey its thanks to staff in the next communication

#### **Action JW, HB**

**Understanding and Responding to the Wider Societal wider societal impacts of Coronavirus and measures taken to control its transmission**

MB outlined the series of actions that he and his team were taking to foster a better understanding of the impact of COVID-19 measures on the broader health of the population. The Board report included a diagram setting out a systemised approach to intelligence gathering, including: COVID Health Impact Assessment (HIA); National Public Engagement Survey; International Horizon Scanning; Dashboard of broader health trends.

MB noted the sharing of the weekly survey results on the Public Health Wales website from now on, and the circulation of the same. The results could inform future planning and gauge levels of public acceptance of, compliance with, any new measures.

The report on the wider implications on population health was nearing completion and TC confirmed that this would be submitted to Welsh Government next week.

Board members welcomed the update, complimenting MB and his team on the breadth of the work underway; members were interested in hearing more of the dashboard development, international learning and progress with the HIA

**Reporting of COVID Deaths (ref [4.1.3.300420](#) and ref [4.1.4.300420](#))**

QS explained the background to, and the outcome of, the review of the reporting of COVID deaths at health board level. He would now be holding weekly assurance meetings with health board medical directors and the Welsh Government chief statistician.

The Board **resolved** to note the update about the Public Health Wales response to the COVID-19 pandemic.

**PHW61/2020 Screening Programmes in Wales**

The Board **received** the Screening Programme update (ref [4.2.300420](#)).

QS rehearsed the reasons for suspending five of the national screening programmes from 18 March 2020; this mirrored the decision taken in Scotland and N. Ireland- England had a decentralised programme model, so there has been no corresponding national position statement.

The report set out how the Screening Division had worked to reduce the impact of the suspensions and had redeployed staff to support the covid-19 response; it also updated the Board on the three programmes still operating: ante-natal screening, new-born blood spot and hearing programmes.

QS then summarised the continuing provision through which symptomatic patients access assessment and treatment in respect of breast, cervical and

bowel cancer services. He explained the reasons for the suspension of colonoscopy services and the identification of an alternative patient pathway.

KE sought more information on the work underway to assess the potential harms resulting from the programmes' suspension; SP echoed this point, reiterating the importance of understanding the harms resulting from screening disruption. He also raised the issue of rebuilding public confidence in accessing NHS services and the role of COVID-19 testing in supporting the resumption of some services. JR noted the variable uptake of screening programmes pre-COVID, and the importance of focussed public engagement.

QS welcomed the comments and briefed the Board on the work underway at UK and Wales levels, the latter involving the Welsh Cancer Network and the Welsh Screening Committee. He reported on the consideration being given to the role of testing in supporting the resumption of certain surgical procedures; and confirmed that the Screening Division had already begun to consider the public engagement requirements.

JW confirmed with KE that the next Quality, Safety and Improvement Committee would include an item on screening programmes; RB-W advised that she could report no issues with the supply of PPE.

JW thanked QS and the Screening Division for the report, and Board members for their contributions to this important debate.

The Board **resolved** to note the current position of the screening programmes, and how the Screening Division had worked to reduce impacts and realigned itself to support the COVID-19 response.

## **PHW62/2020      Governance Arrangements**

The Board received the Governance Arrangements paper (ref [4.3.300420](#))

HB summarised the purpose of the report as offering assurance that the Board and the organisation was maintaining good governance during the COVID-19 response; she confirmed the matters still reserved to the Board for decision in line with the Board scheme of delegation; and drew attention to the section on providing advice to Welsh Government. The Board's role in developing the Public Health Protection Response Plan had exemplified the provision set out.

TC explained the rationale for modifying the organisational management arrangements for the next phase of the COVID-19 response; the programme management board structure was set out in appendix two.

The Board **resolved** to:

- **Approve** for the period of the coronavirus pandemic that the Board would reduce the agenda and focus on essential business only;

- **Adopt** the working principles and ways of working to be agreed and applied during this period;
- Take **assurance** from the operational management structure in response to the COVID-19 pandemic.

**PHW63/2020 Integrated Performance Report**

The Board **received** the Integrated Performance report (ref [4.3.300420](#)).

HG introduced the report, noting the provision of data in dashboard form and the focus on reporting against four domains: COVID-19 response; Finance; Workforce; Performance Indicators.

The COVID-19 report provided high level surveillance data, of the kind the Board was now used to seeing extracted from the daily summaries.

HB drew the Board's attention to the year-end position and the work underway on the Annual Accounts. TC commented on the significant support from Welsh Government finance colleagues in turning around requests quickly and the Board agreed to place its appreciation on record.

The workforce data prompted discussion on the interpretation of staff sickness absence and the policy for staff testing; the Board noted the role that QS undertook in this respect.

QS and RB-W reported on the provisions made by the GMC and NMC, respectively, on revalidation and MB noted the need to check this for non-medical public health professionals.

PB reported on the stable nature of the general workforce indicators, with HB noting that a number of the business as usual indicators would remain static, given the suspension of many work programmes.

SP welcomed the dashboard approach, and particularly the linkage with the dashboard MB had referred to earlier on wider population health indicators. The suite of dashboards would facilitate comprehensive oversight. JW echoed this, thanking all those responsible for the dashboard design and development. She asked KE and DE to consider how the dash boards could be used at committee level.

The Board **resolved** to note the report, which provided an update on current performance management and monitoring.

**PHW64/2020 Strategic Risk Framework**

The Board **received** the Strategic Risk Framework (ref [4.5.300420](#)).

The Board considered the Strategic Risk Framework and noted the updates provided.

HB reported that this was very much a status report, given the organisation's mobilisation in support of the COVID-19 response. She referenced the need to review those strategic risks that reflected the environment facing Public Health Wales in the coming months and to frame a strategic risk specifically relating to the pandemic. HB advised that she, RB-W and John Lawson would be meeting shortly, to review the risk landscape and reflect on the in-year risks.

TC supported a review, and asked for the outcome in time for the May Board meeting; she also suggested that, once the Welsh Government has published its COVID-19 response plan, the Board could consider the specific risks for Public Health Wales in one of its briefing sessions.

DE also supported this approach, considering that the pace of change warranted a dynamic approach to risk reviews.

### **Action: HB, RB-W, JL**

The Board **resolved** to:

- **Note** the revised "due dates" summarised in Table 1 that the Audit & Corporate Governance Committee would be asked to consider at their next meeting;
- Take **assurance** that the Strategic Risk Framework had been reviewed and updated.

### **PHW65/2020      Corporate Risk Register**

The Board **received** the Corporate Risk Register (ref [4.6.300420](#)).

RB-W highlighted the inclusion of 10 new risks, all COVID-19 related. The current operating environment called for heightened scrutiny of risks and she acknowledged the need to review all risks, as the distinction between strategic and operational risks was not as clear cut as in times of business as usual. RB-W also referenced the risks identified in the PESTEL analysis included in the Public Health Protection Response Plan.

The Board took **assurance** that the corporate risks of the organisation were being managed appropriately.

### **PHW66/2020      Standing Financial Instructions**

The Board **received** the Financial Authority Arrangements paper on Standing Financial Instructions (ref [4.7.300420](#)).

The Board considered the report, which recommended two changes to delegates finance limits and set out the rationale for these.

HG assessed the level of risk around the operational cost of addressing the pandemic, noting the level of support from Welsh Government to date.

DE acknowledged the need for agile and rapid decision-making in these unparalleled times.

The Board **resolved** to:

- **Approve** option (2) in relation delegated financial limits:-
  - delegate to the Chief Executive the ability to commit financial resources up to £1m
- **Approve** option (1) in relation to Procurement Thresholds & processes:-
  - a. suspend the SFI Procurement thresholds as outlined but retain the relevant procurement processes (e.g. requisitioning, ordering etc).
  - b. the requirement to seek approval from the Audit and Corporate Governance Committee for contracts, goods or services requiring a STA/SQA be temporarily suspended.

#### **PHW67/2020      Committees of the Board: Report from Committee Chairs**

The Board **received** the composite report from the Committee Chairs' (ref [4.8.300420](#)).

#### **Audit and Corporate Governance Committee**

DE introduced the report from the meeting on 19 March 2020, which followed on from the verbal update he had provided at the previous Board meeting. He confirmed that the next Committee meeting would focus on the end of year financial accounts.

The Board **noted** the report from Committee Chair of Audit and Corporate Governance Committee.

#### **PHW68/2020      Ratification of Chair's Action and Affixing of the Common Seal**

The Board **received** the Ratification of Chair's Action and Affixing of the Common Seal report (ref [4.9.300420](#)).

The Board resolved to **ratify** the Chair's Action to approve the financial limit of the Deputy Chief Executive Officer and Executive Director of Finance and Operations, to be increased to the CEO Delegated financial limit, and DoR designated limits for the Deputy Director of Finance and Operations.
