PUBLIC HEALTH WALES RESEARCH MISCONDUCT POLICY

Policy Statement

Public Health Wales expects all research undertaken within the organisation to be conducted according to the highest standards of research practice and in accordance with all relevant regulatory requirements.

Policy Commitment

The aim of this policy is to protect the safety, well-being, dignity and rights of research participants and to support staff responsible for investigating allegations of misconduct in a thorough and fair manner. This reflects our commitment to having robust systems and processes in place to prevent or detect research misconduct.

The policy for investigating allegations of research misconduct promotes consistency across the NHS by following the model procedure recommended by the UK Research Integrity Office (UKRIO) at <http://www.ukrio.org/publications/misconduct-investigation-procedure/>
