
Covid Population Health Group Showcase 2021-2022



Over the past two-years, Public Health Wales has played a critical part in the control of COVID-19. Our expertise has influenced the identification of infection, underpinned advice on self-protection and informed the necessary restrictions put in place across Wales in order to minimise the spread of the virus. However, even in the early stages of pandemic it was clear that such dramatic changes to people's live would have profound repercussions for their immediate and long term mental and physical health. We required new information on how people were coping with greater isolation, restrictions on their movements and less access to services. We needed to understand how other countries were coping with new ways of living and working, learn from them and help them learn from us. Further, although the pandemic was the predominant concern for people and public health professionals, we still needed to ensure that other existing and potential threats to people's health were monitored, assessed, and addressed as the pandemic progressed. In order to meet many of these challenges, Public Health Wales established the Population Health Group, pulling individuals together from across the whole organisation in order to consider and help address the broader harms arising from or continuing through the pandemic. With a little funding and a lot of good will and enthusiasm, the group and the staff they represent have undertaken critical work to influence how we and others protect and promote broader health throughout the pandemic. As pandemic restrictions recede, and the attention of our whole organisation moves back to population health and inequalities, here we have pulled together a record of some of the accomplishment of PHG.

I have had the pleasure of chairing this group through the pandemic and would like to thank my vice-chairs (Tracy Black and Sally Attwood), all members of the group and the wide range of staff across Public Health Wales who have contributed their work and dedication throughout. Thanks is also due to the Executive and Board for recognising the need to address broader health issues during the pandemic and creating the resource and space to make this possible. I hope that we are not faced with another crisis like COVID-19 for many, many years. However, should another pandemic emerge, I hope the learning from the Population Health Group means that we are well prepared for many of the inevitable challenges it will present to public health in Wales.

April and May 2021 Trade and Health Masterclasses

The Role:

These were held to enable health and other interested stakeholders to better understand the Brexit Trade Cooperation Agreement and the upcoming Comprehensive and Progressive Trans Pacific Partnership Pact.

The Impact:

Led to the establishment of a Devolved Administrations health and trade group which meets quarterly in order to understand each other's work and how we can advocate for health and equity.



Communities4Change Wales Blueprint

The Role:

Evidence informed Communities4Change Wales blueprint developed for accelerating collaborative action on the wider determinants of health.

Approach piloted with Cwm Taf Morgannwg Health and Housing Partnership to develop an information sharing mechanism for health and housing partners.

The Impact:

Blueprint being put into action to strengthen collaborative working between health, housing and local authority partners in a pilot across Cwm Taf Morgannwg.

May 2021

Be the Change Well-being Goals Challenge

The Role:

Sets out six separate behaviour change challenges that inspire us to act to live more sustainably. They are designed to be undertaken on your own, with your team mates or as a team to team challenge.

Drawing on Wales' Well-being Goals and the wider United Nations Sustainable Development Goals, the challenges focus on Slow Fashion, Plant-based Diet, Towards Zero Waste, Healthy Travel, Ethical Consumer and Supporting Wildlife, with sustainable steps provided to guide you on your challenge journey.

Highlights each and every one of us has a part to play in securing the future for our planet and in 'being the change' towards the Wales we want for our current and future generations.





May 2021

Be the Change: Sustainable Home & Agile Working

The Role:

Provides ideas, examples and simple steps to support individuals to work sustainably at home, to help improve Wales' well-being now and in the future.

Provides sustainable steps covering IT, mental well-being, lunch, commuting and travel Highlights how the simple steps supports Wales' well-being goals and the United Nations Sustainable

Development Goals. The Impact:

Includes case studies from staff within Public Health Wales and across partner organisations and provides information and links for people to learn more to improve their sustainable behaviour while working at home or agilely.

May August and November 2021 Green Opportunities e-briefing (Summer, Autumn and winter editions) The Role:

The quarterly updates capture learning to aid Wales' green recovery from COVID-19, identifying sustainable opportunities to support population health – and receive positive feedback from partners. Each e-briefing has a different themes, linked to the World Health Organisation Manifesto for a Healthy and Green

Recovery from the pandemic, but keep the same sub headings to support the priorities of the Public Health Wales Population Health Strategic Group.

Themes covered to date include the impact of COVID-19, energy and air pollution, sustainable and active travel, biodiversity and waste minimisation/ circular economy.





June 2021 #SafeToSay Campaign Phase One The Role:

This pilot sought to encourage prosocial bystander responses toward individuals who demonstrate inappropriate and harmful behaviours in the night time economy.

An evaluation of phase one is soon to be published and a second phase of the campaign is currently underway, following additional funding from the Home Office Safety of Women at Night Fund.

The Impact:

A post-campaign public survey found that 71% of the 265 respondents felt that the campaign helped people know how to intervene safely when they witnessed sexual harassment or violence.

Of those who had seen the campaign whilst it was live, 44% felt the campaign helped them recognise sexual violence, 26% felt the campaign increased their confidence to take action and 42% felt the campaign provided them with the information they needed to take action.



June 2021

Report: A basic income to improve population health and well-being in


Wales?

The Role:

This report was aimed at decision-makers considering basic income in Wales, drawing together international examples of policy design and implementation.

The Impact:

The report introduced the concept of basic income, appraised the evidence from pre-existing schemes and trials, provided evidence to inform the debate, to support future decision-making, and shape thinking for further research and led to the author being seconded to Welsh Government to help design and deliver their basic income pilot.



June 2021

Voices of Carers during the COVID-19 Pandemic: Messages for the future of unpaid caring in Wales

The Role:

The findings were discussed by Dr Daniel Burrows and Chris Williams, a social work practice educator and trainer in a Podcast on ExChange (CASCADE) in August 2021,

The findings were also presented to the Children's Commissioner for Wales (August 2021).

The Impact:

Cardiff University is organising a workshop in March 2022 which will bring together unpaid carers and carer groups, policy makers and researchers to discuss recent research findings and identify future research priorities.



June 2021

Wales Violence Surveillance System Evaluation

The Role:

Wales Violence Prevention Unit commissioned the first independent evaluation of the Wales Violence Surveillance and Analysis System (WVSAS). This system enables the Violence Prevention Unit to produce Violence Monitoring Reports, which bring together data on violence from organisations across Wales to help identify trends and inform violence prevention activity.

The Impact:

The evaluation found that since the Violence Monitoring Reports began in April 2020, the number of agencies contributing data has increased from five to 22, indicating enhanced collaboration enabled by the WVSAS.

In the evaluation, 90% of survey respondents agreed that through its Violence Monitoring Reports, the Violence Prevention Unit is facilitating multi-agency data sharing for the purposes of violence prevention across Wales.

The majority (97%) of survey respondents supported the development and continuation of the Violence Monitoring Report, which will be delivered through the Violence Prevention Unit's Violence Intelligence for Prevention Hub.

June 2021

Who are most vulnerable to employment changes during the COVID-19 pandemic? Key findings from a national survey The Role:

Presented at the Good Work, Good Health: Securing Our Future conference (7th June 2021), hosted by Public Health Network Cymru and with Dr Frank Atherton, Chief Medical Officer for Wales as keynote speaker.

The Impact:

The abstract was featured in the Public Health Science Conference (26th November 2021) Published in BMJ Journal of Epidemiology & Community Health.









July 2021 Emerging Drivers of Vulnerability to Health Inequity in the Context of COVID-19

Impact:

Featured in EuroHealthNet Magazine, December 2021.

Voluntary/Community Sectors across Wales recognised the report as an important piece of work for the voluntary sector The report was discussed at the Vaccine Equity Committee and 'unanimously welcomed' by the members of the committee Dr Sally Rees, National Third Sector Health and Social Care Manager at WCVA said "The findings from this research highlights the important role the VCS has played, from the outset, in supporting vulnerable people in our communities during COVID-19. As this research identifies, there is a need for a co-ordinated approach that values, understands and acknowledges the role the sector in the co-design and co-delivery with citizens of sustainable, well-resourced voluntary and community-based services now, and in the future to reduce the prevalent health inequalities across Wales."

The Impact:

The toolkit supports staff, on an individual level or by working together as teams, to become 'change makers' by helping them to put into practice the principles of sustainable development.



Wales and the global goals infographic

The Role:

The Wales and the global goals infographic provides a background summary of the global and Wales' approaches to sustainable development, including the steps to deliver the global agenda in the Well-being of of Future Generations (Wales) act 2015. The infographic includes:

A literature review on embedding Wales' Sustainable Development Principle ('five ways of working') Annual 'Well-being of Wales Report' on progress towards sustainable development.

Wales' national indicators to measure progress and a short case-study on Wales' 'Health in All Policies' approach to public policy.





August 2021 International Horizon Scanning and Learning to Inform Wales' COVID-19 Public Health Response and Recovery

The Role:

Different aspects of COVID-19 reviewed and summarised with full referencing throughout to enable quick access to reliable information and evidence.

The Impact:

International evidence and good practice shared weekly at the height of the pandemic and more recently monthly, with policy makers influencing the topics to be considered and utilising this in decision making.

Thirty seven reports produced to date with a calendar showing the timeline and evidence at different stages of the pandemic and a summary report on health inequalities published.

Bystander Experiences of Domestic Violence and Abuse during the COVID-19 Pandemic

September 2021 Bystander Experiences of Domestic Violence and Abuse during the COVID-19 Pandemic

The Role:

This research by the Wales Violence Prevention Unit in collaboration with the University of Exeter, explores the experiences and behaviours of bystanders to domestic abuse during the COVID-19 pandemic, to help inform policy and bystander intervention training programmes in light of the changes to daily lives brought about by COVID-19 restrictions.

The Impact:

The research was featured on BBC Wales broadcast, radio and online.

The Violence Prevention Unit hosted a webinar to mark its publication, with 145 attendees. 85% of post-webinar survey respondents rated the webinar as very good or excellent and 93% rated it as very or extremely helpful, with collaboration and information sharing mentioned positively in feedback.

The Wales Violence Prevention Unit have been invited to the European Network on Gender and Violence Conference to present the research.

September 2021

Closing the educational engagement gap for young carers.

The Role:


This Research Briefing reports on the detrimental impact caring responsibilities have on young people's education and the

relationship this has with deprivation.

The Impact:

Members of the Senedd requested to see the infographic.

The findings were also presented to the Children's Commissioner for Wales (August 2021) Kate Cubbage (Head of External Affairs, Carers Trust Wales): "We strongly welcome today's publication which makes a useful contribution to our understanding of the interrelation between young carers, poverty and education. I can't tell you how valuable this evidence will be in helping to shape the Unpaid Carers Strategy Delivery Plan. We've really struggled to prove many of the things the publication demonstrates. This work will significantly improve our ability to influence key education focused actions within the delivery plan."



September 2021

What Works to Prevent Violence against Women, Domestic Abuse and Sexual Violence (VAWDASV)?

The Role:

This research, delivered by the Wales Violence Prevention Unit and funded by Welsh Government, identifies effective primary and secondary prevention interventions for VAWDASV, to inform the adoption of evidence-based policy and practice.

The Impact:

In the first instance, this report has been used to inform the Welsh Government's VAWDASV Strategy Refresh The report has been viewed 530 times on the Violence Prevention Unit website, and it has been accessed 513 times from the initial mailout to stakeholders. The publication's launch tweet earned 22,000 impressions and a 2% engagement rate. The report has been presented at 8 meetings with senior stakeholders and partners within Wales and across the UK, including the Youth Endowment Fund, Scottish Government and Public Health Scotland, and the Metropolitan Police.

September/October 2021

Public Services Boards workshop: future trends and local well-being

assessments

The Role:

A series of four workshops for Public Service Boards to support them to think long-term and use future trends in their wellbeing assessments by introducing them to practical tools.

The Impact:

This round of well-being assessment is significantly improved in terms of futures and the long-term way of working according to The Future Generations Commissioner for Wales analysis.

Rising to the Triple Challenge of Brexit, COVID-19 and climate change: Strategic Overview

October 2021

The Role:

The report provides a strategic overview of the cumulative and interconnected health and well-being impacts of Brexit, COVID-19 pandemic and climate change in Wales and the 'triple challenge' that this poses for the population. It identifies the key social determinants and population groups affected by this Triple Challenge and provides some key examples i.e. health behaviours such as alcohol and those on low incomes and fishers and farmers. It highlights the important pathways of impact for example, the content of Free Trade Agreements.

The Impact:

The report is aimed at a wide range of audiences including public bodies, public health and policy officials but will also have huge relevance to the Third Sector and wider civil society.

The Role:

The project consisted of two phases with employees at Cwm Taf Morgannwg University Health Board (CTMUHB). In Phase 1 36 interviews were conducted with CTMUHB employees to explore the barriers and facilitators influencing influenza and COVID-19 vaccine uptake using the COM-B model. Using the findings from Phase 1, Phase 2 co-production workshops were then held with CTMUHB to design interventions to support influenza and COVID-19 vaccination uptake using the COM-B model and the Behaviour Change Wheel.

The Impact:

Cwm Taff Health Board and Sheffield Hallam University organised a webinar to discuss the findings in March 2022. The report was used by Health Boards across Wales to inform best practices around vaccine roll outs among NHS employees. It was shared with the National Influenza Action Group and with the Vaccine Equity Committee.

October 2021

What could post-Brexit trade agreements mean for public health in

Wales?


The Role:

A briefing for public health professionals and officials who are interested in how Brexit and trade agreements may affect their work, and for those in trade policy to raise awareness of public health impacts.

The Impact:

Raised the profile of Public Health Wales as a stakeholder in trade policy. For example: PHW is now a member of WG's Trade Policy Advisory Group, Public Health Wales is being actively consulted by the Trade Justice Wales stakeholder alliance, Public Health Wales is working with Public Health experts from England, Scotland and NI on trade and health issues.





November 2021 Unpaid carers in Wales: The determinants of mental wellbeing The Role:

The aims of this study are to understand the association between caring intensity and mental wellbeing for unpaid carers in Wales and whether this differs across demographic groups and to examine the impact of socio-economic position (employment and education) on average and gradations of mental wellbeing among unpaid carers with different levels of caring intensity. **The Impact:**

Welsh Government launched the Strategy for Unpaid Carer: delivery plan. The plan identified this programme of work as sources of evidence to measure success and progress across all four of the key priorities identified in the plan in the Strategy for Unpaid Carers.

The report was presented at the Royal Statistical Society Conference in September 2021.

Carers Trust Wales organised a Lunch and Learn in February 2022 to discuss the findings.

Julie Morgan MS (The Deputy Minister for Social Services): "The physical and emotional impact of caring can be overwhelming and it is vital we support unpaid carers in looking after their own health and wellbeing. These studies will help us all to improve outcomes for unpaid carers and increase wellbeing, educational attainment and employment opportunities."

November 2021 COVID-19 in Wales: The impact on levels of health care use and mental health of the clinically extremely vulnerable

The Role:

The aim of this short report is to describe the characteristics of the CEV population in Wales and examine changes in secondary health care activity and the mental health of this population during the COVID-19 pandemic.

The Impact:

The findings were discussed in form of a briefing and article by the Health Foundation. The findings were also presented to the Children's Commissioner for Wales.




November 2021 Global Citizenship Modules


The Impact:

It was launched at the Wales for Africa Health Links Network Conference in November 2021 and has been very positively received.

It has been utilised both internally to the NHS in Wales for example, Public Health Wales ESR platform but externally – for example, the Global Health module at Cardiff University. Several stakeholders have expressed an interest in using the platform including in the Third sector.

Unpaid carers in Wales: The creation of an e-cohort to understand longterm health conditions amongst unpaid carers in Wales

The Role:

This is the first study in Wales providing a comprehensive assessment of the prevalence of physical and mental long-term health conditions and multimorbidity as managed in primary care amongst unpaid carers, and compared to a matched comparison group of non-carers in Wales.

The Impact:

Carers Trust Wales organised a Lunch and Learn in February 2022 to discuss the findings.

Swansea University, presented the methodology used for the creation of this e-cohort during the Public Health Science Conference.

Welsh Government launched the Strategy for Unpaid Carer: delivery plan. The plan identified this programme of work as sources of evidence to measure success and progress across all four of the key priorities identified in the plan in the Strategy for Unpaid Carers.

Claire Morgan (Director of Carers Wales): "The use of an e-cohort of carers in this research, which we were pleased to support, has added an important new dimension to our understanding of the negative health and wellbeing impacts on this group."

The Role:

Webinar to explore what trade agreements are and why they have important potential consequences for health and well-being in Wales as well as future public health policy.

The Impact:

Watched by nearly 40 people from Public Health Wales, health boards, third sector and Welsh Government. Attendees said they would share with colleagues and discuss content to inform action, and find further information. PHNC had new members join due to the webinar.

Inequality in a Future Wales: Areas for action in work, climate and demographic change


The Role:

The Impact:

Received significant media coverage and engagement.

Has led to many public bodies contacting the Future Generations Commissioner to speak in more detail about inequalities. Has been recommended as important reading for PSBs in feedback by the Commissioner on their well-being plans.

The Role:

40 stakeholder engagement sessions held internally and with external organisations and groups.

The Impact:

Feedback presented in a stakeholder engagement report and is informing development and build of the Solutions Platform in readiness for launch in summer 2022.

January 2022 Navigating the Storm Animation

The Role:

Collaborative piece between the ACE Hub and Wrexham Glyndwr University (WGU), created by students to help people understand what it is to be trauma informed and how we can all do it.

The Impact:

Positive feedback on how impactful the animation is and has the potential to be used on a global platform. The animation was launched by Lynne Neagle and received high profile attention.

February 2022

Self-isolation confidence, adherence and challenges: behavioural insights from contacts of cases of COVID-19 starting and completing self-isolation in Wales

This report shares evidence about confidence to self-isolate and the challenges of self-isolation among contacts of COVID-19 in Wales, and makes recommendations for public health communication and interventions to support self-isolation

adherence. The Impact:

A summary of the report was presented to Welsh Government in the form of a slideshow to inform policy and action The work was presented at the Public Health Science Conference: The chair of the session, Dr Dale Weston, who is Principal Behavioural Scientist at the Public Health Advice, Guidance and Expertise Function at the National COVID-19 Response Centre said that the report was used to inform some of their work in the Response Centre at Public Health England.

February 2022 Creating Healthy Places and Spaces: a collaborative approach conference

The Role:

The Conference was organised to help understand the major challenges facing communities including the COVID-19 pandemic impacts.

The Impact:

104 delegates attended Welsh Health Impact Assessment Support Unit conference hosted by Public Health Network Cymru. Highest attendance was from Local Authority (42%) colleagues.

Engagement with planners positively received "Hope to see more events like this, and engagement with the planning system in general".



February 2022 Public Health Network Cymru

The Impact:

1,958 members in February – an increase of 12% since March 2021.

9 webinars, including themes on broader harms of Covid since April 2021 with an audience of up to 179 at a single event and two conferences.

New website in August 2021 with 95,698 page views since launch of which 40% were new visits.



February 2022

Call to Action Online workshops for all NHS Wales Staff

The Role:

The Call to Action workshops were help to enable individuals to identify actions to help reduce their impact on climate change, as well as identifying actions for NHS Wales, to transition to a low –carbon Welsh NHS.

8 workshops held, catering for 100 members of staff.

The Impact:

Raised awareness of the threat of climate change and impact on health and well-being. Identified actions for both work and home life, to support Public Health Wales and NHS Wales to reduce emissions to achieve net carbon zero.





SIFT Healthy Environment Train the Facilitator Workshops

The Role:

Free training for 36 individuals from public bodies across Wales via online workshop to train facilitators to deliver the SIFT healthy Environment workshop within their own organisation.

The Impact:

The workshops were very popular – oversubscribed with a waiting list of people keen to attend The Healthy Environment Workshop has been developed as an online activity to enable teams to identify their environmental impacts - to reduce the negative and maximise the positive impacts. The workshop looks at the activities of the whole team as well as the individuals within the team.

Helped to inform Welsh Government's decision to make funding available for grass roots organisations which we administered with South Wales Police.


Be the Change Sustainable Procurement E-guide

Carbon Literacy Project



March 2022

Carbon Literacy Training for PHW staff

The Impact:

The Carbon Literacy training ensures that every participant understands the links between human activity and climate change while empowering individuals, communities and organisations to take action to reduce emissions of carbon dioxide and greenhouse gases.

Encourages people to learn together, sharing knowledge and experiences along the way. Five cohorts of training being held for 150 members of staff.

March 2022

Public Health Wales' Draft Decarbonisation Plan

The Role:

Developing Public Health Wales' Draft Decarbonisation Action Plan, in line with the requirements of the NHS Wales Decarbonisation Strategic Delivery Plan (SDP).

The plan will identify actions under the six headings identified within the NHS Wales Decarbonisation SDP and include details on timescales and responsibilities for delivering individual actions.

The plan is being developed with involvement from staff across all eight directorates in Public Health Wales. **The Impact:**

13 workshops were held in December to engage with staff and capture their ideas on what should be included to help reduce emissions.

The plan will also highlight the links between biodiversity, the Well-being of Future Generations (Wales) Act and help embed the five ways of working into delivery of actions.
