Covid-19 Vaccine Guidance for employers

As Covid-19 vaccination increases throughout the UK, employers should think about the implications for their staff, visitors and workplace as a whole including: communication to encourage take up; risk assessment; and vaccine policy.

Employers will also need to take account of contractual terms and data protection, disciplinary, grievance and dismissal policies. The Chartered Institute of Personnel and Development (CIPD) has published a **guide** for employers on the implications of Covid-19 vaccination on the workplace, addressing issues such as adopting your

own vaccination policy and managing employees who cannot, or refuse to, be vaccinated.

From February to May this year, phase 1 of our **<u>Status Check</u>** programme saw a total of 52 organisations achieving a revalidation to their existing Corporate Health or Small Workplace Health Award.

Delivered in conjunction with Emma George Consulting, the Status Check offers

organisations an opportunity to retain their current HWW Award level via a short assessment to explore ongoing commitment to the health and wellbeing of staff. The check also considers new developments or approaches implemented in response to the pandemic to instigate new ways of working and protect employees' wellbeing.
